Last year, Michael was a 6th grader who was struggling in class and also finding it hard to make friends. Michael had been living in hotel rooms for a few months until being taken in by his grandmother. After being recommended for the Eagle Foundation's summer Buddy Program by his counselor, Michael was paired with Ben (a CV graduate and education major), his "Big Buddy" for six weeks. They spent Monday through Friday together along with the other students and mentors doing typical summer activities like hikes through White Rocks and Darlington Trail, swimming and fishing at Pine Grove, taking part in a scavenger hunt through historic Carlisle, and spending a day volunteering at Project Share.

Following the program, his grandmother said "Michael has been more talkative. I don't have to coax him out of his room and he wants to talk about what he has done at 'camp' each day." Michael's school counselor indicated he had blossomed. He is willing to raise his hand in class and even asked his counselor how he could get involved in the track team.

We are grateful to you for helping Michael and other CV students who participate in the Buddy Program and get the opportunity to be paired with a mentor and learn life-long social and problem-solving skills.

Thank you for enriching our community by funding educational student services and resources for the District to achieve its goals. **This year, donors giving \$125 or more** will be eligible to receive two athletic passes good for admission to regularly scheduled home athletic events in 2020-2021. Those eligible to receive athletic passes **will receive them in the mail** shortly after the contribution is recorded at the Foundation office.

As a 501(c)(3) organization, your donation to the Eagle Foundation (EIN #25-1780658) is tax-deductible to the extent of the law. Understand if you take advantage of collecting athletic passes and/or reserved football tickets, you may be ineligible to claim that portion of your contribution as a tax deduction since the value of the items exceeds your contribution. Contact your personal tax advisor for details.

* Athletic passes are good for admission to regularly scheduled home athletic events within the 2020-2021 season. Passes must be used by the individual whose name appears on the pass and cannot be transferred. At this unique time in our world, athletic schedules may be subject to change.
