As the CVSD student population continues to grow at an astonishing pace, so do the needs of our students. **Today, almost 28% of CVSD students come from low-income households, a significant increase from the 20.5% just five years ago.** This means that right now, 2,804 students in our district are facing various challenges and require our immediate support.

To address these pressing needs, the Eagle Foundation established the Access to Opportunities Committee. This committee funds crucial initiatives such as college visits, providing our students with the chance to explore the vast possibilities that higher education holds. It ensures that students attending summer school sessions have breakfast, setting them up for a day of productive learning. Additionally, the committee supports Eagle Mart, a facility that resembles a store where students can access essential items free of charge, from personal care products to backpacks, sneakers to clothing, and even household cleaning products or a mattress if they don't have one.

Understand if you take advantage of collecting athletic passes and/or reserved football tickets, you may be ineligible to claim that portion of your contribution as a tax deduction since the value of the items exceeds your contribution. Contact your personal tax advisor for details.

* Athletic passes are good for admission to regularly scheduled home athletic events within the 2023-2024 season. Passes must be used by the individual whose name appears on the pass and cannot be transferred.

▲ Includes premium reserved tickets to the spring musical (no ordering necessary). Musical tickets will be mailed to you in advance for one of the selected performances.

◆The Eagle Foundation will host the recognition dinner on April 28, 2024 at the West Shore Country Club.
